## GUIDANCE FOR PRIVATE SCHOOLS THAT INTEND TO PARTICIPATE THE IMPLEMENTATION OF LIMITED FACE-TO-FACE CLASSES

- 1. The Office hereby informs the more than 200 private schools that are under the jurisdiction of SDO Cebu Province to comply the stipulations of DepEd-DOH JMC No. 1, s. 2021 dated 27 September 2021 as regards to the opening of limited face-to-face classes. Additional information about the opening of the limited face-to-face classes is also stipulated in DepEd Memorandum No. 71, s. 2021.
- **2.**Application folders need to be submitted at the Schools Governance & Operations Division (SGOD) with the following important documents:
- 2.1 Letter-request addressed to the Regional Director channeled to the Schools Division Superintendent;
  - 2.2 PTA Resolution:
  - 2.3. Sangguniang Barangay resolution;
  - 2.4. School's Organizational Chart indicating grade levels;
  - 2.5. Pictures of Classroom Restructuring;
- 2.6.Copies of the vaccination cards of the teachers, school head/s and nonteaching staff.
- 2.7.Letter-consent from the municipal mayor and the rural health unit/rural health physician in the municipality;
  - 2.8. Machine copies of the vaccination cards of the learners (Grade 7 to 12);

- 2.91. Machine copy/photocopy of the filled-up School Safety and Assessment Tool (SSAT);
  - 2.92 Machine copy of the permit to operate or certificate of recognition;
  - 2.93. Proposed implementation plan (refer to DepEd-DOH JMC No. 1, s. 2021);
  - 2.94 Contingency plan (if a covid case will happen in the barangay);
  - 2.95 Pictures of the school clinic with the needed medical kits/supplies;
  - 2.96 Pictures of handwashing facilities in the school; and
  - 2.97 Pictures of the exit and entrance gates of the school;
  - 2.98 Parental consent (parents/guardians of the learners); and
- 2.99 Other documents that may support the school's application for limited face-toface classes.
