7. For both Secretariat and Call Center, the District Chair shall choose any DepEd personnel who are committed to do the job.
8. You are entitled to have an overtime pay for your services on May 9, 2022 or three (3) days service credits/CTO/Leave credits, subject to availability of funds and existing auditing rules and regulations as well as pertinent Civil Service Law.
9. All concerned personnel are hereby directed to accomplish Daily Time Record (DTR) and prepare an Accomplishment Report. Submit the said documents to this Office on or before May 13, 2022.
10. Travelling, food (meals and snacks) and other incidental expenses to be incurred by each personnel shall be chargeable against School/Division Funds, subject to usual accounting and auditing rules and regulations.
11. This Memorandum serves as **Authority to Travel**.
