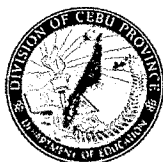

1. As DepEd Cebu Province enwraps the New Normal setting of learning delivery modalities for our Cebuano learners, this Office will conduct an End-of-Year Accomplishment Conference and Action Plan for SY 2022-2023 for All District Partnerships Focal Persons on July 11-12, 2022 at 8:00AM – 5:00PM at Ecotech Center, Lahug, Cebu City.
2. Participants to this Conference are the 58 District Partnerships Focal Persons with the Division Partnerships Focal Persons, DPFPs TWG, and Division PFPs. TWG and participants from the island are allowed to be at the venue on Day 0.
3. Participants are expected to make available the following reports for submission both in printed copy and soft copy, to wit;
 - a. District Consolidated Report on BE Resource Generated from January to June 2022
 - b. District Consolidated Report on LGU Donations through the Special Education Fund (SEF)
 - c. District Consolidated Report on List of Partners with the corresponding donations and amount
 - d. Action Plan for SY 2022-2023 and Accomplishment Report for SY 2021-2022
4. This Memorandum serves as an Authority to Travel of the participants.
5. Informing the field that participants must be fully vaccinated and must present their vaccination card upon entry to the venue. Unvaccinated participants must present negative antigen results valid within 48 hours prior to arrival at the venue upon entry. Requesting 2 Division Nurses to be at the venue to attend to some health concerns and observance of health protocols.
6. Meals, snacks, accommodation, venue rental, tarpaulin, and other incidental expenses shall be chargeable against Division HRD/MOOE/Other Funds while traveling expenses of the participants shall be chargeable against School MOOE/Local School Funds.
