**REITERATION OF THE IMPLEMENTATION OF MODULAR DISTANCE  
LEARNING AS PROVIDED IN DEPED ORDER NO. 037, s. 2022**

To: Assistant Schools Division Superintendents  
Division Chief, CID and SGOD  
Education Program Supervisors/Division Coordinators  
Public Schools District Supervisors/OICs  
Public Elementary and Secondary School Heads

1. **Attached is OASOPS Memorandum No. 2023-077 which reiterates DepEd Order No. 037, s. 2022** titled "Guidelines on the Cancellation or Suspension of Classes and Work in Schools in the Event of Natural Disasters, Power Outages/Power Interruptions, and Other Calamities" **providing for the implementation of modular distance learning (MDL) in the event of cancelled or suspended classes due to natural disasters, calamities and human induced hazards** considering the welfare of the students who are adversely affected by extreme climate conditions when they attend in-person sessions but still ensure learning continuity and that learning competencies and objectives are met.
2. Attention is invited to paragraph no. 2 of Memorandum OASOPS No. 2023-077 on the authority and responsibility of school heads.
3. However, school heads and teachers will still report to school as usual and shall inform this office when they start implementing MDL and submit a report on how they implement modular distance learning in their respective schools, indicating the mechanics of the implementation of the MDL. (Attention: Dr. Fay C. Luarez, ASDS in-charge of CID) School Heads are further reminded that the implementation of the MDL is intended to spare our learners and personnel from the ill-effect of exposure to extremely hot weather condition.
4. Public Schools District Supervisors are instructed to monitor the implementation of MDL in school.
5. Wide dissemination of and strict compliance of this Memorandum is desired.
