Demonstration Mechanics and Interview Guidelines

1.0 Demonstration Mechanics

1.1 Topic

1.1.1 Each applicant will be given a topic for demonstration. The SDRRT Applicants will prepare a **10-minute demonstration** for the topic below. The topic will be provided in advance to give the applicants ample time to prepare for their Slide Decks (PPT Presentations) and Session Guides.

Demonstration Topic:	Conducting hazard and vulnerability assessment and risk analysis (structural and non-structural) for a school with community participation
Deadline of Slide Deck (PPT) & Session	*May 15, 2023 (Monday) or five (5) to seven (7) days after the release of the DepEd Regional Memorandum

Note: The applicants must submit their PPT Presentations and Session Guides on or before the deadline. Late submissions will be automatically disqualified.

- 1.1.2 The applicants must explain the chosen topic. They can use PowerPoint Presentations, videos, or other visual aids to enhance their presentation but must **not exceed the allocated 10 minutes per applicant.**
- 1.1.3 The applicants must ensure their demonstration follows local and international Disaster Risk Reduction (DRR) concepts, principles, and applications.

1.2 Online Platform

- 1.2.2 The demonstration will be conducted online via **Microsoft Teams.** The link and password will be sent to the applicants' email addresses.
- 1.2.3 The applicants must have a stable internet connection and ensure that their audio and video equipment functions well during the demonstration and interview. The applicants will be given access to share their screens during the demonstration.
- 1.2.4 When joining **Microsoft Teams** via the link, applicants must wait in the **Lobby** (the equivalent of the **Waiting Room in Zoom**). When it's their turn for the demonstration and interview, the SEED Asia technical team will allow the applicant to enter the Room. After their turn, they will be requested to leave the Room for the remaining applicants to join.
