**INTERIM GUIDELINES OF THE LEARNER GOVERNMENT PROGRAM (LGP)  
FOR SCHOOL YEAR 2022-2023**

To: Schools Division/City Superintendents  
Officers-in-Charge of Regular/Interim Divisions  
All Others Concerned

1. Attached is a Memorandum from the Office of the Undersecretary for Operations through the Bureau of Learner Support Services-Youth Formation Division dated May 05, 2023 on the 1) renamed Learner Government Program (LGP) from Student Government Program (SGP) hereby renaming the Supreme Pupil Government (SPG) and Supreme Student Government (SSG) to Supreme Elementary Learner Government (SELG) and Supreme Secondary Learner Government (SSLG) respectively; 2) schedule on the conduct of SELG and SSLG elections in preparation for SY 2023-2024; and the 3) interim guidelines of the LGP with the following annexes on the Constitution and By-Laws, Learner Government Election and Appointment Code (LGEAC) and the Guidelines and Procedures in the election of officers.

3. All public elementary and secondary schools are mandated to facilitate learner-led clubs and organizations' elections and other relevant practices that will meaningfully support learners' initiatives and respond to varied contexts.
4. **To establish the supremacy and representation of the SELG and SSLG among all clubs and organizations, it is recommended that only federations of SELG and SSLG be established within the field offices.** However, field offices may still establish federations for other clubs and organizations depending on the context of the locality upon the approval of Schools Division Superintendent and Regional Director for division/district-level federations and regional-level federations, respectively.
