This has reference to the correspondence from the Office of the Undersecretary for Curriculum and Teaching dated April 11, 2023 requesting for the commitment of the Regional Directors, Schools Division Superintendents, and School Heads in putting up or maintaining an infrastructure that makes reading materials available for all learners to support the Department's thrusts in improving quality basic education.

Relative to the said request, this is to resterate further to maintain the established Learning Resource (LR) facility in the Regional Offices (ROs), Schools Division Offices (SDOs), and schools as it serves multipurpose functions on various LR processes and activities.
