**REITERATION ON THE VOLUNTARY PARTICIPATION OF TEACHERS
IN THE NATIONAL LEARNING CAMPS**

1. Pursuant to DepEd Order (DO) No. 014, s. 2023 titled Policy Guidelines on the Implementation of the National Learning Camp (NLC), the Office of the Secretary reiterates that the participation of teachers in the NLC is **strictly voluntary**.
2. In view of such, no teacher shall be forced to participate in the NLC. It is likewise emphasized that the non-participation of the teachers in the NLC shall not be taken against them in any manner.
3. This Office enjoins the division and regional offices to ensure the proper implementation of the aforesaid DO, particularly on the voluntary participation of teachers.
