As stipulated in DepEd Memorandum No. 82 s. 2017 titled "*Learning Resource Management and Development System Implementation in the Rationalized DepEd Structure*", the **Department of Education Learning Resource (LR) Portal** is the official source of all DepEd-developed and DepEd-approved teaching and learning resources. The LR Portal is consistent with the LDRMS processes and contains learning resources listed in *Annex A*. It also links users to free LRs that can be used to develop teacher-made resources, including copyright-free videos and images developed by other government agencies and partners such as the National Library and the Department of Science and Technology, among others.

In this regard, Regional Offices (ROs) and Schools Division Offices (SDOs) are requested to actively promote the maximum use of the curriculum-aligned learning resources at the DepEd LR Portal. The LR Portal is accessible through <https://lrnds.deped.gov.ph/>.

Digital files of the guide on how to register to the LR Portal and the list of available quality-assured learning resources in the portal can be accessed at <http://bit.ly/LRPpubLRs23> for your information and reference.

ROs, through the Regional LR Supervisors, are further requested to ensure that local quality-assured learning resources, especially materials for mother tongue-based (MTB) learning for Kindergarten to Grade 3, Science and Technology, and Mathematics, are uploaded and information about the available LRs are regularly updated.

Similarly, the SDOs, through the Division LR Supervisors, are requested to coordinate with School LR Coordinators in conducting LR mapping in schools and orienting teachers on the use and navigation, and downloading of LRs in the LR Portal through appropriate workshops/training. They shall also ensure a program for the reproduction of LRs, giving priority to schools that do not have sufficient funds.

School LR Coordinators are expected to:

- a. share the benefits of accessing the LR Portal;
- b. conduct semi-annual updating of teachers and learners on the LRs in the LR Portal;
- c. submit LRs to SDOs through the Division LR Supervisors for further handling and uploading in the LR Portal; and
- d. request funds for and oversee the production of LRS at the school level.

The LRs in the Portal can be printed using allowable funds from the Maintenance and Other Operating Expenses (MOOE), Special Education Fund (SEF), canteen, or any other local funds. Please refer to DepEd Order No. 8, s. 2019 or the *Revised Implementing Guidelines on the Direct Release, Use, Monitoring and Reporting of MOOE Allocation of Schools, Including Other Funds Managed by Schools* and the DepEd-DBM-DILG Joint Circular No. 2, s. 2020 or the *Addendum No. 2 [Clarification to DepEd-DBM-DILG Joint Circular No. 1, s. 2017 titled "Revised Guidelines on the Use of the Special Education Fund (SEF)"]*. This will allow ROs, SDOs, and schools to immediately address shortages and other specific LR needs.

Types of Learning Resources in the LR Portal and Its Brief Description

No.	Type of Learning Resource	Brief Description	Purpose	Intended User/s
1.	Learner's Material	These are learning resources that are completely and sufficiently developed based on the prescribed learning competencies and curriculum standards for a specific grade level in a target subject area.	It is produced for use for the learners in all grade levels. The name of this resource type varies depending on who developed the resource; Learner's Material if it is in-house developed by DepEd personnel.	Learners
2.	Teacher's Manual and Teacher's Guide	These are learning resources that provide learning objectives, suggested teaching-learning strategies, developmental activities, and evaluative measures that complement with the contents of the accompanying Learner's Material or Textbook for a specific grade level in a specific subject area.	The Teacher's Guide help teachers in preparing a unit of work that integrates the basic skills of learners while the Teacher's Manual is designed to provide teachers with rubrics, scaffolding activities, other supplemental material to help educators/teachers in the class.	Teachers/Educators
3.	Reader	The reader is a comprehensive but brief learning resource that provides authoritative information on a specific topic. It represents the best example of knowledge in a discipline and presents specific ideas of authors with different perspectives.	A reader is used by learners to read, reflect, and respond. Teachers use readers to guide discussions with consideration for age-appropriateness and time allotment. It is most suitable for topics with general coverage and not sequential or are stand-alone topics.	Teachers/Learners
4.	Storybooks	The storybook is a book containing a story or collection of stories intended for children.
