**CORRIGENDUM TO DIVISION MEMORANDUM NO. 265, s. 2023 ENTITLED
“CAPACITY BUILDING OF GRADE 7 & 8 TEACHERS ON THE
IMPLEMENTATION OF THE NATIONAL LEARNING CAMP (NLC)
”**

1. This has reference to Division Memorandum No. 265 entitled “**Capacity Building of Grade 7 & 8 Teachers on the Implementation of the National Learning Camp (NLC)**” on July 19-21, 2023 at DepEd Ecotech Center, Sudlon, Lahug, Cebu City.



2. Item No. 7 of the Memorandum now reads as follows:

*“Expenses incurred such as accommodation, materials/supplies, meals and snacks of the participants, resource speakers and members of the Program Management Team (PMT) shall be charged against the **Program Support Fund for Capacity Building on the Implementation of the National Learning Camp (NLC)**, all subject to their availability and the usual accounting and auditing rules and regulations.”*

3. Item No. 8 of the Memorandum now reads as follows:

*“Members of the PMT/Facilitators are directed to be at the venue on Day Zero (July 18, 2023) to conduct ocular inspection of the venue and prepare the training materials/supplies to be used during the L&D program. Accommodation, afternoon snacks and dinner of the members of the PMT, speakers/facilitators on Day Zero as well as breakfast on Day One shall be charged against the **Program Support Fund for Capacity Building on the Implementation of the National Learning Camp (NLC)**, all subject to their availability and the usual accounting and auditing rules and regulations.”*

4. All other provisions stated in the Division Memorandum No. 265, s. 2023 remain in effect.
5. Wide dissemination of and strict compliance with this Memorandum are directed.
