

As part of the MATATAG Agenda particularly on the component **G: Give Support to Teachers to Teach Better**, all ancillary functions of teachers shall be unloaded for them to focus more on their teaching tasks, DRRM Coordinatorship included. Given this pronouncement, the Disaster Risk Reduction and Management Service is now coordinating with the Bureau of Human Resource and Organizational Development to resolve this challenge.

In relation thereto, and with the issued *OUOPS No. 2023-04-6762* titled *Guidelines on the Utilization and Reporting of the Fiscal Year (FY) 2023 Disaster Preparedness and Response Program (DPRP) Funds (Annex A: Implementing Guidelines on the use of FY 2023 DPRP Funds for DRRM Programs, Projects, and Activities, Item 2-H)* that provide one-time load expenses for the School DRRM (SDRRM) Coordinators, the DRRMS hereby issues this advisory to **suspend the payment/release of the said provisions until such time that the agency has clarified the qualifications of the designated SDRRM Coordinators.** The DRRMS will issue an official correspondence regarding this concern.
