They shall use the DepEd Evaluation Rating Sheet for Supplementary Learning Resources (SLRs) to assess the suitability for school libraries and library hubs and to ensure that SLRs are free of any kind of errors.

4. Membership to the Division SLR Committee is considered an additional ancillary task and does not entitle the members to additional remuneration, honoraria, and other similar allowances pursuant to Section 4.5 of DBM Budget Circular 2007-1 s. 2007.
