H. Mr., Miss and Queen DERESA (3 entry per division) Opening Day



- 2. The opening will be on December 17, 2023 (Sunday) at Mandaue City Division the host Division for this year's tournament. It will start with the registration, to be followed with a simple parade, short program, search for Mr., Ms. & Queen DERESA 2023 and game proper in the afternoon. Each team shall be responsible of their own provisions. Host division is providing billeting quarter only.
- 3. All participating teams are required to attend the parade and opening program on December 17, 2023 (Sunday) at Mandaue City. Failure to attend the said event 5 points plus to their opposing team in basketball and volleyball until the end of the elimination round.

- 4. During the Registration, the team shall:
 - a. must submit the credentials required placed in a folder (Official line-up, Medical Certificate/waiver.
 - b. certificate of employment, Photocopy of appointment of the teacher-player;
 - c. DepEd I.D photocopy and duly accomplished DERESA membership form).
- Registration fee of Php800.00 per player in all event and membership fee of Php200.00 per player shall be paid on or before December 17, 2023, through our DERESA treasurer.
- FIBA, FIVB, Lawn Tennis, Chess, Billiard, Badminton, Sepak Takraw, and Table Tennis Rules and Regulations shall be followed respectively, however, the committee can modify the rules as need arises. The Committee's decision is, at all times, final.
- The registration fee, uniform, transportation expenses and other relative to these activities shall be charged against School GAD Fund/Division MOOE/SEF/PTA/GAD or other funds subject to usual accounting and auditing rules and regulations.
- Enclosed are the list of requirements for eligibility of players/personnel for the tournament.

RULES AND REGULATIONS

ELIGIBILITY

- 1. All players must be a permanent employee of Department of Education Region VII (Please refer to above specification of number of players per event). Official line-up should have their Item-Plantilla verified and signed by their Division Administrative Officer. NO APPROVED PLANTILLA- NO PLAY POLICY
- 2. A team can field **ONE TEACHER FROM A PRIVATE SCHOOL** as being part of DepEd Family (no more-no less). Provided, this private school teacher shall be on a teaching capacity task NOT coach or trainer of their school Varsity team. The team should submit a **NOTARIZED appointment or NOTARIZED contract of employment** indicating his teaching position and class taught prior to the start of the tournament.
- 3. To be eligible to participate in this tournament, a player must be in **active status** (not substitute or on leave) employee of the participating team for no less than (6) six months prior to the opening.
- 4. NO team/division may recruit or accept players coming from the other school division(s), even for the reason that the said division has already completed line up (for partiality of the game) EXCEPT for the REGIONAL OFFICE ONLY wherein limited personnel is a consideration. However, players who wish to participate to the tournament from other division who is not competing for the tournament he/she will automatically be able to do so provided he/she acquires approval from his/her head of office (SH/Admin/ASDS/SDS) to participate for such tournament for and EXCLUSIVE ONLY for Regional Office team.
- 4. To promote friendship and more involvement, Cebu Province team are requested to field two teams (one from North areas and one from the South areas)
- 5. All players are required to submit eligibility form with 2x2 picture.
 - a. Photocopy of appointment (prior to the game all team captain/coach will have an allotted time to scrutinize or check the other team's roster) freshly verified/signed by the administrative officer
 - b. Copy of medical Certificate duly signed by medical doctor.
 - c. Picture Gallery (CERTIFIED BY THE SDS/ASDS/CHIEF SGOD OR CID)
 - d. DERESA Membership Form
- 6. Rules stipulated and agreed on DERESA tournament should be and always respected "NO PALAKASAN SYSTEM" should be entertained "RULES IS RULES". No further intervention and amendments of the rules when the tournament starts. All corrections and amendments must be done before the tournament.
- 7. Joining fee of 800.00 pesos per player per event is to be paid on or before December 17, 2023
