

**ANNOUNCING THE TENTATIVE COMPARATIVE RANKING RESULTS OF
APPLICANTS FOR ADMINISTRATIVE ASSISTANT II AND III POSITIONS OF
SDO CEBU PROVINCE FOR THE CALENDAR YEAR 2023**

1. The Division of Cebu Province hereby informs the field of the Comparative Assessment Results-Registry of Qualified Applicants (CAR-RQA) of Administrative II and III applicants of SDO Cebu Province.
2. The CAR-RQA is posted for a period of **ten (10) calendar days** which will end on **December 28, 2023 (Thursday)**. However, applicants are only given **five (5) calendar days** to raise corrections on the scores or ratings they obtained as per DO No. 007, s. 2023 which took effect on April 7, 2023 (Paragraph/Item 34). The reglementary period of the **five-day posting period** will end on **December 23, 2023 (Sunday)**.
3. Applicants who will raise corrections or clarifications on the scores obtained must send or submit a letter request addressed to the schools division superintendent channeled to the HR Unit or through the HRMPSB not later than December 5, 2023. If no corrections are raised by any of the applicants, the **Rank List is deemed considered final and executory, reposting is no longer necessary after the lapse of the five-calendar day or ten-calendar day posting period.**
4. The Rank List will be used to fill up the existing ADAS II and III vacant positions due to retirement, resignation, or other modes of separation. **This Rank List shall be valid until December 31, 2024.**
5. Widest dissemination of this Memorandum is hereby directed/desired.
