7. This serves as Authority to Travel of the participants.
8. Traveling and other incidental expenses of the participants shall be chargeable against School MOOE/SEF/PTA and other Local Funds while food and venue shall be charged against GAD Funds, subject to the usual accounting and auditing rules and regulations.
