Members of the Division Task Force District (PSDS or their representative and Lead Secondary Principals or their representative) are expected to extend assistance to the Regional Task Force during the ocular inspection of the private schools.
4. The members of the Regional Task Force assigned to Cebu Province will be conducting ocular inspection individually and separately among the districts of the division to ensure that the ocular inspection shall be completed as scheduled.
