REITERATION OF MEMORANDUM OASOPS NO. 2023-077 TITLED “REITERATION OF THE IMPLEMENTATION OF MODULAR DISTANCE LEARNING AS PROVIDED IN DEPED ORDER NO 037, S. 2023”

1. In the interest of the welfare and safety of our learners and DepEd personnel, this office reiterates OASOPS No. 2023-077 which reminds School Heads of their authority and responsibility to suspend in person classes and implement modular distance learning in cases of unfavorable weather and environment, including extremely high temperatures.
2. Attached is a copy of Memorandum OASOPS No. 2023-77 for your guidance.
3. School Heads are to inform the Public Schools District Supervisors should Alternative Delivery Mode shall be adopted due to the unfavorable environmental conditions such as but not limited to extremely high temperature. Public Schools District Supervisors shall report to the Division Office (Attention: Mr. Emmanuel E. Mendoza) the schools adopting Alternative Delivery Mode and shall monitor its implementation.
4. In the event that the Chief Executive of the Local Government Unit declares suspension of classes, Alternative Delivery Mode will be automatically adopted. In addition, a copy of the Executive Order of the LGU declaring the suspension of classes shall be submitted to this office (Attention: Mr. Emmanuel E. Mendoza).



SUBJECT : **Reiteration of the Implementation of Modular Distance Learning as Provided in DepEd Order No. 037, s. 2022**

DATE : April 20, 2023

In consideration of the well-being of the learners affected by extreme climate conditions as they attend in-person classes, **this Office reiterates DepEd Order No. 037, s. 2022**, titled *"Guidelines on the Cancellation or Suspension of Classes and Work in Schools in the Event of Natural Disasters, Power Outages/Power Interruptions, and Other Calamities."* DO 037, s. 2022 **provides for the implementation of modular distance learning¹ in the event of canceled or suspended classes** due to natural disasters, calamities, and human-induced hazards to ensure learning continuity and that learning competencies and objectives are met.

Additionally, and in relation to the announcement of the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA) last March 21, 2023, which marked the beginning of the warm and dry season in which warmer temperatures are expected, **this Office reminds School Heads of their authority and responsibility**, consistent with Rule VI, Section 6.1 of DepEd Order No. 01, s. 2003 or the *Implementing Rules and Regulations of Republic Act No. 9155*, **to suspend in-person classes and implement modular distance learning in cases**
